SPONSORS: Linn County Izaak Walton League and Iowa State Rifle & Pistol Association

LOCATION: The range is located at 5401 42nd St. NE, Cedar Rapids, IA

FACILITIES: This 50-foot range has 8 firing points with turning targets. Social distancing will be practiced. Club house and restrooms will be available. Over \$70,000 has been spent this year improving shooter comfort and adding state of the art air handling for shooter safety.

OFFICIAL: Randy Snook – Match Director

ELIGIBILITY: Open to all competitors.

ENTRIES: Entries will be accepted until both relays both days are filled.

MATCH FEES: Entry fee: \$30.00 Payable to Linn County IWLA (Izaak Walton League of America)

RULES: Current NRA Rules for indoor pistol competition will govern the match. Sponsors will score and post targets. Scores will be official 1 hour after all same day scores are posted.

Due to short notice, this State Championship is not an NRA registered or approved match.

CLASSIFICATION: The NRA classification will be used. Unclassified competitors will fire in their own class. Four competitors must be entered in the High Master/Master class before a first Master award will be given.

SAFETY: All competitors are required to wear eye and ear protection.

PROGRAM: Competitors will fire 10 shots per target in matches #1 thru #3, and 5 shots per target in matches #5 thru #11
